

## **INDIAN INSTITUTE OF FOREIGN TRADE**

### **Selection Criteria for Full Time MBA(IB) and MBA(BA) 2026-28 Programmes**

The admission to IIFT's Full Time MBA (IB) and MBA(BA) 2026-28 programmes is on the basis of CAT 2025 score, Group Discussion (GD), Personal Interview (PI) and other parameters i.e. Gender Diversity, Academic consistency and Work Experience. The process will be carried out in two stages as follows:

#### **Stage 1: (Short listing):**

The short listing of candidates for Group Discussion and Personal Interview will be done on the basis of CAT 2025 percentile and score including sectional cut offs, work experience and Gender Diversity.

#### **Stage I (Weightage by using Rating Scores for Work Experience) :-**

**Stage 2: (Group Discussion and Personal Interview):**

The shortlisted candidates of stage-1 will have to appear for Group Discussion and Personal Interview.

\*\*If applicants have covid batch at any level of 10<sup>th</sup>, 12<sup>th</sup> and graduation, due to that the score/percentage at any one level (10<sup>th</sup>, 12<sup>th</sup>, or Graduation) may not be available, then corresponding weight may be redistributed among the remaining levels to consider the weightage of academic consistency.

For the candidates who are in their final year/semester of graduation, the CGPA/percentage obtained till last year/semester will be considered if the final result is awaited.

Work experience and academic consistency will be calculated as per Appendix-II
