Members of IQAC met the chairmanship of The Director and The Chairman of IQAC on 08<sup>th</sup> March, 2016 and discussed the academic administrative audit report pertains to academic year 2015-16 at 10:30 a.m. All members were present.

The following points regarding the audit were noted for action.

- The IQAC team recommended setting up of 'Incubation Cell' in line with NAAC recommendation, in the next AY itself.
- 2. The IQAC team recommended initiative of full course review of MBA (IB) curriculum which should revisit the course credits & introduction of possible course electives.
- 3. The IQAC team recommended that effort should be made by the Research Division to improve publication of Policy Research Programme.
- 4. It is strongly recommended that the completion of PhD reports by the Research Scholar should be properly assessed to ensure timely completion of the work.
- 5. The members of IQAC has recommended strengthening the library database with subscription of Bloomberg Terminal.
