- 2. The Institute invites sealed bids for providing **two numbers** of 250 mbps (1:1) Internet Lease Line (ILL) through Fibre Cable, one each from different class 'A' / UASL Internet Service Providers, registered in India (certificate need to be attached), under terms and conditions given in Tender Document.
- 3. The bid should be submitted along with DD in favour of "Indian Institute of Foreign Trade" payable at "New Delhi" for Rs.200/- towards the cost of Tender Document. - 4. The technical and financial bids should be sealed by the bidder in separate envelopes duly super-scribed and both these sealed envelopes are to be put in a bigger envelope which should also be sealed and dulysuper-scribed.

2 The Institute invites sealed bids for providing **two numbers** of 250 mbps (1:1) Internet lease Line (ILL) through Fibre Cable, from class 'A' / UASL Internet Service Providers, registered in India (certificate need to be attached), on following terms and conditions:-

## **Terms and Conditions**

- a) The prescribed tender document consisting of (i) Technical Bid and (ii) Financial Bid, sealed separately in two different envelopes, superscribing "<u>Technical Bid</u>" and "<u>Financial Bid</u>", as the case may be and placed in a duly sealed big single envelop superscribing "<u>Bid for ILL Services for IIFT</u>, New Delhi" may be submitted in the name of Section Officer (General Admn.), at the Main Gate, Indian Institute of Foreign Trade, B-21, Qutab Institutional Area, New Delhi- 110016 by 5.00 p.m on 10/08/2021. The bids may be sent through post also so as to reach at the aforesaid address by 5.00 p.m of due date.
- b) The bidder shall provide at least three customer references to whom similar services are being provided during last one year with their contact details.
- c) Financial Bids will be opened only of those bidders, who will qualify on the basis of technical bids. Institute's decision, in this regard would be final.
- d) Rates must be quoted only in the prescribed format of Financial Bid as attached.
- e) The Institute at its discretion may award the contract for providing ILL services of 250 Mbps (1:1) to two different ISPs through Fibre Cable. The Institute decision in this regard would be binding on allbidders.
- f) Successful bidder(s) shall be required to install and operationalize the link within 15 days of award of contract, failing which the bank guarantee will be forfeited. The Institute may also take action as it deems fit against such firm(s).
- g) Payment shall be released at the end of every three month of services subject to the services being found satisfactory to be certified by the authorized IIFT personnel.
- h) The Institute reserves the right to reject any or all bids without assigning any reasonswhatsoever.
- Minimum Contract Period is one year, which may be extended on mutually agreed terms and conditions. However, if the services are found not to be satisfactory, contract may be terminated by giving 60 days notice by IIFT, New Delhi.
- j) **The estimated cost of the Tender**: The Tender value is estimated to be Rs. 9.50 Lakhs.
- k) **Earnest Money Deposit:** As per the Ministry of Finance, Department of Expenditure an amendment to GFR Rule 170 vide Office Memorandum No. F.9/4/2020-PPD dated 12/11/2020, the bidders are requested to submit a

- Declaration instead of Bid Security. The declaration format at Annexure-III.
- I) Performance Bank Guarantee: The successful bidder must submit a Performance Bank Guarantee for an amount equivalent to 3% of the order value. It can be deposited in the form of Demand Draft or Bank Guarantee with validity period beyond 60 days of the completion of the contract period.
- m) Force Majeure: (a)In case of any situation, incident or any other act of god which is beyond the control of the agency happened and the agency foresee a delay in accomplishing the Scope of Work, such incident to be immediately reported to the Institute with a request, with proper justification for the expected interruption and duration, for extension of the date of submission maximum for 1 week time. (b) IIFT has the full right to decide the request under Force Majeure based on the factual situation.
- n) **Liquidated Damage**: 2 % per week of delay subject to a maximum of 5% of the order value will be levied for delay in execution of the contract. If the delay is go indefinitely IIFT will decide the liquidated damage caused to the Institute.

Sealed bids in the manner prescribed above may be sent in the name of Section Officer (General Admn.) and deposited / dropped in the tender box kept at the Main Gate, B-21, Indian Institute of Foreign Trade (IIFT), Qutub Institutional Area, New Delhi - 110016 on or before 5.00 PM on 10/08/2021.
