Sl.No.	Pre-bid Query/Suggestions	Comments of IIFT
1.	Is it mandatory to submit copy of Registration with competent authority (Department for Promotion of Industry and Internal Trade(DPIIT) for a bidder from a country which shares a land border with India	It was clarified to the intended bidder that this is required only from those bidders who are from a country which shares a land border with India. (Ex. Nepal, China)
2.	Is MSME certificate sufficient to get exemption from EMD	It was clarified to the bidder that MSME or NSIC certificate is sufficient for getting exemption from EMD provided this certificate should be related to the services tendered for.
3.	If the same menu for lunch has to be followed as mentioned in the tender	It was clarified that the menu as given in the tender document has to be followed for serving lunch to the participants of weekend programme on Saturday and Sunday and to the participants of DGR students on week days(Monday to Friday)and if there is some change in the menu, it will be done on mutual understanding. Also the brands of consumables shall be same as mentioned in the tender

4.	Clarification regarding License Fee and Consumption Security Deposit	License fee of Rs.20,000/- per month including electricity and water charges will be paid by the selected contractor. In addition to License fee, selected vendor has to pay IGL charges. Also the selected contractor has to pay refundable consumption security deposit amounting to Rs.60,000/- for the use of IGL Connections
5.	TDS Certificate for Work Experience	In case the work experience is of Pvt. Sector the completion certificate shall be supported with copies of Letter of award and copies of corresponding TDS Certificates. Value of work will be considered equivalent to the amount of TDS Certificate.
6.	Whether Institute shall provide crockery	It was clarified to intended bidder that crockery has to be provided by bidder at his own cost.
