1.	One of the vendor enquired that the capacity of their building is more than 120 students. Whether students of other Universities /Colleges can be accommodated in the same building?	It was clarified that there is no objection for accommodating the students of other Universities/Colleges in same building provided separate floors are identified for IIFT.
2.	How Electricity and Water Charges shall be paid by the Institute.	It was clarified that a separate sub-meter can be installed for the floors occupied by the IIFT and Electricity charges shall be paid as per sub-meter. As regards water charges, it was clarified that these shall be paid on pro-rata basis for the number of floors occupied by IIFT.
3.	Whether utensils and baneberries shall be provided by the Institute.	Attention of the vendor was drawn to point no. 10 on page 10.
4.	Duration of contract is 12 months. For some period students will not be in hostel, then how the payment of mess facilities shall be regulated.	It was clarified that payment shall be made as per clause 8 "schedule of submission of bills" for the actual work done on monthly basis.

5.	Whether triple occupancy is acceptable.	Not acceptable.
6.	Whether payment shall be on monthly basis or quarterly basis.	It was clarified that payment shall be made as per clause 8 "schedule of submission of bills" for the actual work done on monthly basis.
7.	Whether date for submission of tender can be extended.	Not agreed.
8.	Whether sub-contract in respect of housekeeping and security is permitted.	Yes agreed.
