Terms and Conditions:-

- i) Vendor has to submit EMD amounting to Rs.5,000/- in favour of Indian Institute of Foreign Trade, New Delhi.
- ii) Vendor has to deposit applicable TCS and GST (as per applicable rates) in addition to the value of goods.

(iii) All goods must be transported/lifted within 48 hours from the date of receipt of order, otherwise the institute will not be liable for any damages.
