### 2. Background:

- The firm/applicant at their own must visit and examine the probable sites of work and its surroundings and obtain all information that may be necessary for execution of work prior to submitting the bid for actual assessment of the work.

### 5. Scope of Work:

1. The approximate total area is 7 acres. The site is not empty and houses several high value Clusters, Servers, UPS's and many other related equipment and devices which are very crucial in the day to day working of the Centre and are running 24x7 throughout the year. All of these Clusters, Servers, UPS's and related equipment and devices cannot be shut down completely nor can they be kept shut down for long periods continuously. Any shutdown required should be carefully planned well ahead and would require written request atleast 10 days in advance and co-ordination with the Computer Center. The design and implementation of the Fire Safety solutions thus warrants careful consideration of these facts.
