Note:

- a) The detail of unserviceable vehicles can be inspected physically by prospective Bidders at the respective place during office hours, on "AS IS WHERE IS BASIS".
- b) The successful bidder will be informed as to the acceptance of his/her bid by letter/mobile/e-mail and any other mode of communication.
- c) The successful bidder after acceptance of his / her bid will be required to deposit cost within 02 (two) working days from the date of issue of acceptance letter and will need to lift the vehicle within a specified date from the issue of release order or such period as may be decided by the Institute.
- d) All Taxes and other charges of any nature whatsoever liveable by the govt. shall be payable by the buyer in addition to the price offered.
- e) The vehicle will be sold in the same condition as they exist on "As is where is basis". The buyer shall lift the vehicle within 02 (Two) working days from the date of issue of release order.

- f) The buyer shall make his / her own arrangements for transport and will not be entitled to claim any facility or assistance for transport from the institute. If the original buyer wishes to take delivery of the Vehicle purchased through representative, he must authorize the representative by a letter of authority which shall be presented to the office in which the Vehicle is held.
- g) Lifting of the vehicles by proxy shall be at buyer's sole responsibility and risk. No claim shall lie against the institute on any account whatsoever if delivery effected to a wrong person.
- h) The vehicle sold to the buyer shall be from the date of acceptance of his auction and will be lie at IIFT, New Delhi at his own risk. The institute shall not be responsible for the safe custody or preservation thereof.
- i) If the vehicle is not lifted within the time specified in the release order, the institute may resell the vehicle at the buyer's risk/expense and cost. The buyer shall not be liable to claim the vehicles from the institute at a later stage.
- j) The storage charge will be @1% of the cost per day on sale price of said vehicle thereof on uplifted vehicle, these charges will be recovered before delivery of such items are actually affected or until the date of resale (Inclusive).
- k) Delivery will be given during working hours on all working days on presentation of the release order by the buyer to the stock holder.
- l) If the Buyer does not purchase the Vehicle after the order is placed, the Buyer will be debarred/restricted by the Institution from submitting his/her bids to the Buyer for the next 3 years.
- m) IIFT reserves the right to reject any or all tenders or cancel/withdraw the invitation for bid without assigning any reasons whatsoever thereof.
