#### **GENERAL (COMMERCIAL) CONDITIONS OF CONTRACT (GCC)**

- The general condition shall apply in contracts made by IIFT for Repairing of Variable Refrigerant Volume (VRV)
   Make Daikin Air-Conditioning Sytems for CWS at NAFED Building
- .2. Completion Period: 10 days.
- 2.1 Defect Liability Period: 6 months from the date of handing over the VRV System in running condition.

Note: An amount equivalent to 5% of the bill amount shall be withheld and be released after completion of Defect Liability Period.

Submission of bids: Bids should be submitted as detailed below:-

**Envelope-1**: Bid with all relevant papers duly signed. The envelope should be super scribed as "Technical Bid for Repairing of Variable Refrigerant Volume (VRV) Make Daikin Air-Conditioning Sytems for CWS at NAFED Building."

**Envelope -2** Comprising of Price Bid. The envelope should be super scribed as "Price Bid for Repairing of Variable Refrigerant Volume (VRV) Make Daikin Air-Conditioning Sytems for CWS at NAFED Building".

#### 3. PAYMENTS:

- 3.1 Payments will be made through RTGS (Real Time Gross Settlement) or NEFT (National Electronic Fund Transfer) as the case may be on receipt of the bill along with certification of rectification of defects.
- 3.2 Mandate willing to receive e-payments signed by the vendor shall be submitted by the vendor containing following information at the time of signing of Agreement / Contract.
  - (a) Account beneficiary's name.
  - (b) Account type.
  - (c) Account number.
  - (d) Name of the bank.
  - (e) Bank Branch's NEFT code.
  - (f) IFSC code in case of Transfer through RTGS.

All the above particulars which form the essential element of this mandate may be duly verified by Banker of the vendor.

**4.** Quoted Rates shall be inclusive of all expenses to be incurred by vendor for providing goods and service as specified in the Scope of Work of the quotation excluding GST.

### 5.0 ACTION BY PURCHASER AGAINST BIDDER(S) / VENDOR(S) IN CASE OF DEFAULT:

In case of default by Bidder(s)/ Vendor(s) such as:-

- (a) Failure to deliver and / or commission any or all of the services within the time period(s) specified in the contract, or any extension thereof granted by the purchaser.
- (b) Failure to perform any other obligation(s) under the Contract; and
- (c) If the contractor persistently neglect to carry out his obligation under the contract and / or commits default in complying with any of the term and the condition of contract and does not remedy it or take effective steps to remedy it within the time specified after a notice in writing is given to him in that behalf by purchaser.
- 5.1 When the contractor has made himself liable for any of the cases aforesaid, the IIFT shall have the powers to terminate the contract as aforesaid.

#### 6.0 ARBITRATION:

- 6.1 Except as otherwise provided elsewhere in the contract, in the event of any disputes, controversy or differences arising out of or related to this agreement or the breach, termination or invalidity thereof between the parties, such party or parties shall make a request to the other party or parties to amicably settle such differences or disputes and parties shall thereupon make every effort to settle the same amicably within a period of 60 (Sixty) days from the date of making of such request.
- Where parties are unable to settle the disputes through conciliation, the same shall be referred to the Director IIFT for referral of such disputes to a sole arbitrator, to be mutually decided by the parties, as per the provisions of the Arbitration and Conciliation Act, 1996, any amendment thereof, and any notification issued or rules made there under from time to time. The venue of the arbitration proceeding shall be IIFT Delhi.

#### 7.0 COURT JURISDICTION:

Any dispute arising out of the tender / bid document / evaluation of bids / issue of APO shall be subject to the jurisdiction of the competent court at Delhi only.
