IIFT invites tenders from reputed Security Agencies who have license for providing security services from the Private Security Agency (Regulations) Act 2005 and West Bengal Private Security Agencies (Regulation), Rules 2007 to provide Security Guards in the IIFT campus.

1.0 Sealed tenders in Single Stage Two Envelope method (Part-A: Techno-commercial bid and Part-B: Financial bid) are invited on behalf of the Director IIFT for undertaking following works:

- 2.0 Time Period:- One Year
- 3.0 Purchase of Tender Document:- Tender document can be obtained from Indian Institute of Foreign Trade (IIFT), Plot No. 1583, Madurdaha, Chowbaga Road, Kolkata 700107 on payment of Rs.1,180/- up to 11:00 AM on 08/03/2021. The tender document can also be downloaded from IIFT website www.eprocure.gov.in from 15/02/2021
- 3.1 The bidders downloading the tender document are required to submit the tender fee amounting to Rs.1,180/- (Rupees One Thousand One Hundred Eighty only) through DD / Banker's cheque along with bid, failing which the tender bid shall be left archived unopened / rejected. The DD / banker's cheque shall be drawn from any Nationalized / Scheduled Bank in favour of "Indian Institute of Foreign Trade" and payable at "Kolkata".
- 3.2 The tender documents shall be issued free of cost to NSIC / MSME registered bidders on production of requisite proof in respect of valid certification from NSIC / MSME for the tendered item / services.
- 4.0 Eligibility Criteria:
 - a) The bidder should be registered with Government of West Bengal for engage in the business of Private Security Agency as per The Private Security Agencies (Regulation) Act, 2005 and should furnish Certificate of private security agencies registered under the Private Security Agencies (Regulation) Act 2005/West Bengal Private Security Agencies (Regulation), Rules 2007.
 - b) The bidder should have satisfactorily completed similar work (work of Security Services) during last seven years ending previous day of the last day of the submission of tender as detailed below:

i) ONE similar work of value not less than 80% of estimated cost i.e. **Rs.80,00,000**/- each or more from any Departments / Autonomous Institutions / Public Sector Undertakings of the Government of India / State Government or Public Sector Banks or private organization.

OR

ii) TWO similar works of value not less than 50% of the estimated cost i.e. **Rs.50,00,000**/- each or more from any Departments / Autonomous Institutions / Public Sector Undertakings of the Government of India / State Government or Public Sector Banks or private organization.

- iii) THREE similar works of value not less than 40% of the estimated cost i.e. **Rs.40,00,000**/- each or more from any Departments / Autonomous Institutions / Public Sector Undertakings of the Government of India / State Government or Public Sector Banks or private organization
- c) The bidder should have a valid PAN.
- d) The bidder should have Goods and Service Tax Registration Certificate. Copy of Registration Certificate is to be submitted as part of bid and bidder has to give a self-declaration that bidder is not black listed by GST authorities.

OR

The bidder should produce certificate that bidder is exempted to register under the Goods and Services Tax (GST).

- e) The bidder has to register himself / herself / itself within one month of award of work with the appropriate authorities under Employees Provident Fund and Employees State Insurance Acts, if not already registered.
- 4.1 The experience certificate should be on the letter head of the organization with name, designation and contact number along with the office seal of issuing authority. The Certificate should be signed / issued by the authority not less than the "Gazetted Officer / Manager" rank officer for Govt. / semi govt. / PSU / Private organizations and should be supported by "TDS" certificate, if issued by authorities of private organizations.
- **4.2** The bidders shall submit necessary documentary proof showing that they meet the eligibility criteria along with their tender bid. All documents submitted will also be self-attested by the bidder.
- 4.3 The evaluation and comparison of firm(s) shall be based on quality & cost based selection (QCBS). The final score shall be arrived by adding technical & financial score with respective weightages (50% for technical & 50% for financial). The bidder obtaining the highest combined weighted technical and financial score will be considered for work order. The procedure for technical & financial evaluation is as under:
- (a)Technical evaluations: The firms fulfilling eligibility criteria only shall be considered for technical evaluations. The technical evaluation shall be based on following parameters:

- (i) Experience of providing services to IITs / IIMs/any educational institute of similar repute (minimum 1) 15 marks.
- (ii) Internal communication protocols & license for using bartans, guns etc 5 marks
- (iii)Annual turnover of providing similar services- 10 marks
- (iv) Compliance with Private Security Agencies Central Model Rules, 2020.- 25 marks

A presentation featuring the company's complete work profile along with the above parameters should be presented before the Contract Committee of IIFT, Kolkata Centre. The duration of the presentation should not be more than 10 minutes.

- (b) Financial evaluations: The financial bids of only those bidders shall be considered who secure 60% and above marks in technical evaluation. The maximum financial score of 100 will be given to lowest bidder and other eligible firm given financial scores that are inversely proportional to their prices with respect to the lowest offer.
- 5.0 The bidder has to submit of "<u>Bid Security Declaration</u>" accepting that if they withdraw or modify their bids during period of validity etc., they will be suspended for the time specified in the tender documents.
- **6.0** Submission of Tender bids:- The tender should be submitted as detailed below:-
 - **Envelope-1:** Comprising of Bid Security Declaration and tender document with all relevant papers duly signed. The envelope should be super scribed as "**Technical Bid for Providing Security Services**".
 - **Envelope-2:** Comprising of Price Bid. The envelope should be super scribed as "**Price Bid for Providing Security Services**".
 - Envelope 1 & Envelope 2 shall be enclosed in a big envelope super scribed as "Tender for Providing Security Services" should be submitted to the Section Officer, Indian Institute of Foreign Trade (IIFT), Plot No. 1583, Madurdaha, Chowbaga Road, Kolkata 700107".
- 7.0 Date & Time of Submission of Tender bids: 08/03/2021 at 11:00 hrs.
- 8.0 Opening of Tender bids:
- **8.1** The Tender shall be opened in the presence of intending tenderers or their authorized representatives, who choose to attend, at time & specified date.
- 9.0 Date & Time of Opening of Tender Bids:
- 9.1 Technical Bid:- 08/03/2021 at 11:30 hrs and presentation starts from 12.00p.m.(duration of presentation -10mins wherein the vendors may be required to submit the soft copy)
- **9.2** Financial Bid:- The date will be intimated later on to the responsive bidders only.
- **10.0** Tender bids received after due date & time will not be accepted.
- **11.0** Incomplete, ambiguous, conditional, unsealed tender bids are liable to be rejected.

- **12.0** The purchaser reserves the right to accept or reject any or all tender bids without assigning any reason. The purchaser is not bound to accept the lowest tender.
- **13.0** The bidder shall furnish a declaration in his letter head that no addition / deletion / corrections have been made in the downloaded tender document being submitted and it is identical to the tender document appearing on the website.
- **13.1** In case of any correction / addition / alteration / omission in the tender document, the tender bid shall be treated as non-responsive and shall be rejected summarily.
- **14.0** The supplier has to indemnify IIFT against loss of input tax credit on account of Black-listing of supplier during tenure of contract.
- **15.0** IIFT has the right to recover input tax credit loss suffered by it due to any mis-declaration of invoice by supplier.
- **Note 1:** If date fixed for sale / submission opening of bids is subsequently declared as holiday by the IIFT, the revised date will be notified. In the absence of such notification, the date for sale/submission/opening shall be on next working day, time and venue remaining unaltered.
- **Note 2:** All documents submitted in the bid offer should be preferably in English. In case the certificate viz. experience, registration etc. is issued in language other than English, the bidder shall attach an English translation of the same duly attested by the bidder & the translation to be true copy in addition to the relevant certificate.
- **Note 3:** All computer generated documents should be duly signed / attested by the bidder / vendor organization.

SECTION - 3

SCOPE OF WORK

DUTIES AND RESPONSIBILITIES OF THE SECURITY GUARDS AT IIFT CAMPUS

- To ensure security of movable and immovable property of IIFT against theft or damage. They should take full responsibility on thefts and losses of properties and take immediate action to restore the articles or damages.
- 2. To check people on entry/exit from both the gates and maintain visitors record.
- 3. Thorough checking of incoming and outgoing material against proper Challan/Gate Pass duly signed by the authorized signatory and maintain proper records thereof.
- 4. To ensure that no hawker, marketing persons or vendors are allowed into the campus without permission.
- 5. To bring to notice any suspicious activity observed during discharge of duties by security guards.
- 6. To attend firefighting operations, i.e. capable of handling fire hydrants, wet risers, handling portable fire extinguisher and attending to fire alarm system whenever required.
- 7. To respond to phone calls before and after office hours/holidays and also during working hours if the situation warrants. A record of important calls received during the said period to be maintained and inform the concerned authorities.
- 8. Safe custody of keys of main doors, rooms inside the building/office vehicles etc. and issue to the authorized and designated officers/persons only. Also safe custody of duplicate keys of all locks, including that of all hostel rooms and other places for use in exigencies/emergencies.
- 9. To switch off and switch on electrical switches, closing of water taps etc. after office hours in coordination with Housekeeping and Electrical Maintenance Staff.
- 10. To switch on and switch off the lights installed on top of the buildings in the campus.
- 11. To receive dak at the main gate and arrange for its distribution to concerned officers/staff/students through concerned administrative section.
- 12. To convey message, whenever received, to the concerned officials and to receive urgent mails/telegrams before and after office hours and on holidays.
- 13. To regulate incoming and outgoing traffic at both the gates and ensure that no vehicle is parked in front of the gates and also ensure proper parking of vehicles in the designated parking area of the Institute.
- 14. To keep record of arrival and departure of staff cars/vehicles/ visitors cars & vehicles.
- 15. To switch on and switch off the water motors and water boilers, as and when required.
- 16. Any other related duty assigned by the Institute on need basis.

- 18. Stay calm with an angry clients.
- 19. Deal respectfully with ladies.

- 21. Inform your supervisor/superiors about any unexpected or emergency situation.
- 22. Ensure secrecy of Institute's information.
- 23. Make sure you know your duties/responsibilities at every post.

- 34. Be aware of the actions to be taken in case of any emergency.
- 35. You should know how to frisk and check visitors if required.
- 36. Keep an eye on the movement of personnel and vehicles in your area.
- 37. Be aware of hiding places in vehicles which have to be checked.
- 38. Carry out regular patrolling of your area of responsibility.
- 39. Ensure that all security gadgets in your area are working properly.
- 40. Report any breaches of Security to your superior immediately.
- 41. Ensure proper key management.
- 42. Usage of mobile phones may be limited to official calls and bare minimum to personal calls except in case of emergency
- 43. Barriers to be down/gates to be closed when not in use.
- 44. Make sure the first aid box is available in your post and is to be used in an emergency.
- 45. Make sure you know the types of fire extinguishers and how to use them in case of an emergency.

DON'T's

- 1. Do not leave your post unless permitted by your supervisor or for patrolling.
- 2. Do not allow entry to any unauthorized person into the premises without permission.
- 3. Do not come to work under the influence of liquor/narcotic substances.
- 4. Do not smoke while on duty.
- 5. Do not chew gum or tobacco while on duty.
- 6. Do not sleep on duty.
- 7. Do not engage in unnecessary conversation while on duty.

SECTION - 4

GENERAL INSTRUCTIONS TO BIDDERS (GIB)

1.0 **DEFINITIONS**:

- (a) "The Purchaser" means the Indian Institute of Foreign Trade (IIFT), Kolkata.
- (b) "The Bidder" means the individual or firm who participates in this tender and submits its bid.
- (c) "The Supplier" or "The Vendor" means the individual or firm supplying the goods / services under the contract.
- (d) "The Goods / Services" means all the equipment, machinery, and / or other materials / services which the Supplier is required to supply to the Purchaser under the contract.
- (e) "The Advance Purchase Order" or "Letter of Intent" means the intention of Purchaser to place the Purchase Order on the bidder.
- (f) "The Purchase Order" means the order placed by the Purchaser on the Supplier signed by the Purchaser including all attachments and appendices thereto and all documents incorporated by reference therein. The purchase order shall be deemed as "Contract" appearing in the document.
- (g) "The Contract Price" means the price payable to the Supplier under the purchase order for the full and proper performance of its contractual obligations.
- (h) "Successful Bidder(s)" means the bidder(s) to whom work in this tender is awarded.

2.0 ELIGIBILITY CONDITIONS:

2.1 Kindly refer to Clause 4 of Section – 1 i.e. NIT.

3.0 COST OF BIDDING:

3.1 The bidder shall bear all costs associated with the preparation and submission of the bid. The Purchaser will, in no case, be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

4.0 DOCUMENTS REQUIRED:

- **4.1** The goods/services required to be supplied; bidding procedures and contract terms and conditions are prescribed in the Bid Documents. The contents of the Bid documents are specified in the covering letter.
- **4.2** The Bidder is expected to examine all instructions, forms, terms and specifications in the Bid Documents and clarifications/ amendments/ addenda, if any. Failure to furnish all information required as per the Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect will be at the bidder's risk and may result in rejection of the bid.

5.0 CLARIFICATION OF BID DOCUMENTS:

- 5.1 A prospective bidder, requiring any clarification on the Bid Documents shall notify the Purchaser in writing by FAX or by E-mail of the Purchaser as indicated in the invitation of Bid. The Purchaser shall respond in writing to any request for the clarification of the Bid Documents, which it receives 21 days prior to the date of opening of the Tenders. Copies of the query (without identifying the source) and clarifications by the Purchaser shall be sent to all the prospective bidders who have received the bid documents.
- **5.2** Any clarification issued by IIFT in response to query raised by prospective bidders shall form an integral part of bid documents and shall amount to an amendment of the relevant clauses of the bid documents.

6.0 AMENDMENT OF BID DOCUMENTS:

- 6.1 The Purchaser may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, may modify bid documents by amendments prior to the date of submission of Bids with due notification to prospective bidders.
- **6.2** The amendments shall be notified in writing by FAX or E-mail to all prospective bidders on the address intimated at the time of purchase of the bid document from the purchaser and these amendments will be binding on them.
- 6.3 In order to afford prospective bidders a reasonable time to take the amendment into account in preparing their bids, the purchaser may, at its discretion, extend the deadline for the submission of bids suitably.

7.0 DOCUMENTS COMPRISING THE BID:

The bid prepared by the bidder shall ensure availability of the following components:

- (a) Documentary evidence establishing that the bidder is eligible to bid and is qualified to perform the contract if its bid is accepted in accordance with the Clause 2 & 10.
- (b) Bid Security furnished in accordance with Clause 12.

8.0 BID FORM:

8.1 The bidder shall complete the bid form and appropriate Price Schedule furnished in the Bid Documents, indicating the goods / services to be supplied, brief description of the goods / services, their quantity and prices as per Section- 9.

9.0 BID PRICES:

- 9.1 The bidder shall give the total composite price excluding Goods and Service Tax which will be paid extra. The basic unit price and all other components of the price need to be individually indicated in each column for the services under the contract as per the price schedule given in Section-9 Part-B.
- **9.2** A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected.
- 9.3 "DISCOUNT if any, offered by the bidders shall not be considered unless specifically indicated in the price schedule. Bidders desiring to offer discount shall therefore modify their offers suitably while quoting and shall quote clearly net price taking all such factors like Discount, free supply, etc. into account".

10.0 DOCUMENTS ESTABLISHING BIDDER'S ELIGIBILITY AND QUALIFICATION:

- **10.1** The bidder shall furnish, as part of the bid documents establishing the bidder's eligibility, the following documents (whichever is required) as per terms and conditions of Bid Documents:
 - (a) Valid NSIC / MSME Certificate, if applicable. In case the ownership of such MSE Entrepreneurs happens to be from SC / ST category, proof in this regard also need to be submitted.
 - (b) Documents to establish the eligibility and qualification of bidder as specified in Section-1.
 - (c) Power of Attorney as per Clause 14.3 (a) and (d) and authorization for executing the power of Attorney as per Clause 14.3 (b) or (c).
 - (d) Certificate of incorporation.
 - (e) Article or Memorandum of Association or partnership deed or proprietorship deed as the case may be.
 - (f) Certificate of private security agencies registered under the Private Security Agencies (Regulation) Act 2005/West Bengal Private Security Agencies (Regulation), Rules 2007 (Copy of relevant certificate to be attached.)

11.0 DOCUMENTS ESTABLISHING GOODS / SERVICES' CONFORMITY TO BID DOCUMENTS:

- **11.1** Pursuant to Clause-7, the bidder shall furnish, as part of its bid, documents establishing the conformity of its bid to the Bid Documents of all goods and services which he proposes to supply under the contract.
- **12.0** The bidder has to submit of "<u>Bid Security Declaration</u>" accepting that if they withdraw or modify their bids during period of validity etc., they will be suspended for the time specified in the tender documents.
- **NOTE: -** The bidder shall mean individual company / firm or the front bidder and its technology / consortium partner, as applicable.

13.0 PERIOD OF VALIDITY OF BIDS:

- **13.1** Bid shall remain valid for period specified in Clause-2, Section-2 of Tender Information. A bid valid for a shorter period shall be rejected by the purchaser being non-responsive.
- 13.2 In exceptional circumstances, the purchaser may request the consent of the bidder for an extension to the period of bid validity. The request and the response thereto shall be made in writing. The bid security provided under Clause-12 shall also be suitably extended. The bidder may refuse the request without forfeiting its bid security. A bidder accepting the request and granting extension will not be permitted to modify its bid.

14.0 FORMAT AND SIGNING OF BID:

- 14.1 The bidder shall submit his bid through sealed envelopes complying all eligibility conditions, other terms and conditions of tender document to be read along with the clarifications and amendments issued in this respect. All the documents must be authenticated, by hand signatures, by the authorized person. The letter of authorization shall be indicated by written power-of-attorney accompanying the bid.
- 14.2 The bid shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by the bidder in which case such corrections shall be signed by the person or persons signing the bid. All pages of the original bid, shall be signed by the person or persons signing the bid.

14.3 Power of Attorney

- (a) The power of Attorney should be submitted and executed on the non-judicial stamp paper of appropriate value as prevailing in the concerned states(s) and the same be attested by a Notary public or registered before Sub-registrar of the state(s) concerned.
- (b) The Power of Attorney be executed by a person who has been authorized by the Board of Directors of the bidder in this regard, on behalf of the Company / Institution/ Body corporate.
- (c) In case of the bidder being a firm, the said Power of Attorney should be executed by all the partner(s) in favour of the said Attorney.
- (d) Attestation of the specimen signatures of authorized signatory by the Company's / firm's bankers shall be furnished. Name, designation, Phone number, mobile number, email address and postal address of the authorized signatory shall be provided.

15.0 SEALING AND MARKING OF BIDS:

- (a) The bid should be submitted as per Clause-3, Section 2 of tender information.
- (b) The envelope shall bear the name of the tender, the tender number and the words 'DO NOT OPEN BEFORE' (due date & time).
- (c) The envelope shall indicate the name and complete postal address of the bidder to enable the purchaser to return the bid unopened in case it is declared to be received 'late'.

- (d) The bid should be deposited in the tender box provided by tendering authority or sent by registered post or delivered in person on below mentioned address (address is given in **(e)** below). The responsibility for ensuring that the tenders are delivered in time would vest with the bidder.
- (e) Bids sent by registered post or delivered in person shall be delivered up to specified time & date as stated in NIT to "Section Officer, Indian Institute of Foreign Trade (IIFT), Plot No. 1583, Madurdaha, Chowbaga Road, Kolkata-700107". The purchaser shall not be responsible, if the bids are delivered elsewhere.
- (f) Venue of Tender Opening: The tenders will be opened in the chamber of "Section Officer, Indian Institute of Foreign Trade (IIFT), Plot No. 1583, Madurdaha, Chowbaga Road, Kolkata-700107" at specified time & date as stated in NIT.

16.0 SUBMISSION OF BIDS:

- **16.1** Bids must be submitted by the bidders on or before the specified date & time indicated in Clause-7 of Section-I i.e. NIT.
- **16.2** The purchaser may, at its discretion, extend this deadline for the submission of bids by amending the Bid Documents in accordance with Clause-7 in which case all rights and obligations of the purchaser and bidders previously subject to the deadline will thereafter be subjected to the extended deadline.

17.0 LATE BIDS:

17.1 No bid shall be accepted after the specified deadline for submission of bids prescribed by the purchaser.

18.0 MODIFICATION AND WITHDRAWAL OF BIDS:

- **18.1** The bidder may modify, revise or withdraw his bid after submission prior to deadline prescribed for submission of bid.
- **18.2** Subject to Clause-20, no bid shall be modified subsequent to the deadline for submission of bids.

19.0 OPENING OF BIDS BY PURCHASER:

19.1 The Tender opening committee of IIFT shall open bids in the chamber of "Section Officer, Indian Institute of Foreign Trade (IIFT), Plot No. 1583, Madurdaha, Chowbaga Road, Kolkata-700107", in the presence of the authorized representatives of bidders physically present, who choose to attend, on due date and time specified in Clause-9 of NIT (Section-1).

The bidder's representatives, who are present, shall sign in an attendance register. Authority letter to this effect shall be submitted by the authorized representatives of bidders before they are allowed to participate in bid opening.

- 19.2 A maximum of two representatives of any bidder shall be authorized and permitted to attend the bid opening.
- **19.3** The following information should be read out at the time of bid opening:-
 - (a) Name of the Bidder
 - (b) Name of the item/services
 - (c) Bid validity and acceptability
 - (d) Information in respect of eligibility of the bidder
 - (e) Details of bid modification/ withdrawal, if applicable
 - (f) Name of the item
 - (g) Quantities/prices quoted in the bid
 - (h) Discount, if offered
 - (i) Taxes & levies

19.4 The date fixed for opening of bids, if subsequently declared as holiday by the IIFT, the revised date of schedule will be notified. However, in absence of such notification, the bids will be opened on **next** working day, time and venue remaining unaltered.

20.0 CLARIFICATION OF BIDS:

- **20.1** To assist in the examination, evaluation and comparison of bids, the purchaser may, at its discretion ask the bidder for clarification of its bid. The request for the clarification and the response shall be in writing. However, no post bid clarification at the initiative of the bidder shall be entertained.
- 20.2 If any of the documents, required to be submitted along with the techno commercial and financial bid is found wanting, the offer is liable to be rejected at that stage. However the purchaser at its discretion may call for any clarification regarding the bid document within a stipulated time period. In case of non-compliance to such queries, the bid will be out rightly rejected without entertaining further correspondence in this regard.

21.0 CONTACTING THE PURCHASER:

- **21.1** Subject to Clause-20, no bidder shall try to influence the purchaser on any matter relating to its bid, from the time of the bid opening till the time the contract is awarded.
- **21.2** Any effort by a bidder to modify its bid or influence the purchaser in the purchaser's bid evaluation, bid comparison or contract award decision shall result in the rejection of the bid.

22.0 PLACEMENT OF ORDER:

The purchaser shall consider placement of order only to the eligible bidder based on the final score arrived by adding technical & financial score with respective weightages (50% for technical & 50% for financial).

The decision of the Institute in this regard will be final and binding on the participating agencies.

23.0 PURCHASER'S RIGHT TO VARY QUANTITIES:

Purchaser reserves the right to increase or decrease up to 50% of the quantity of goods and services specified in the schedule of requirements without any change in the unit price or other terms and conditions.

24.0 PURCHASER'S RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS:

The purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds of purchaser's action.

25.0 ISSUE OF ADVANCE PURCHASE ORDER:

- **25.1** The issue of an Advance Purchase Order shall constitute the intention of the purchaser to enter into contract with the bidder.
- **25.2** The bidder shall within 14 days of issue of the advance purchase order, give its acceptance along with performance guarantee in conformity with the Performa provided with the bid document at Section-7A.

26.0 SIGNING OF CONTRACT:

- **26.1** The issue of Advance Purchase order shall constitute the award of contract on the bidder.
- **26.2** Upon furnishing of performance guarantee by successful bidder (pursuant to Clause-27) and signing of contract, the purchaser shall discharge the bid security in pursuant to Clause-12.

27.0 ANNULMENT OF AWARD:

Failure of the successful bidder to comply with the requirement of Clause 27 & 28 shall constitute sufficient ground for the annulment of the award and the forfeiture of the bid security in which event the purchaser may award the work to any other bidder at its discretion or call for new bids.

28.0 QUALITY ASSURANCE REQUIREMENTS:

The quality of services will be monitored by the authorized representatives of the purchaser and their decision in this regard has to be accepted by the contractor.

29.0 REJECTION OF BIDS:

- **29.1** While all the conditions specified in the Bid documents are critical and are to be complied, special attention of bidder is invited to the following clauses of the bid documents. Non-compliance of any one of these shall result in outright rejection of the bid.
 - (a) Clauses 12.0 & 13.1 of Section-4: The bids will be rejected at opening stage if Bid Security Declaration is not submitted as per Clauses 12.0 and bid validity is less than the period prescribed in Clause 13.1 mentioned above.
 - (b) Clause 2 & 10 of Section-4: If the eligibility condition as per Clause 2 of Section-4 is not met and / or documents prescribed to establish the eligibility as per Clause 10 of Section-4 are not enclosed, the bids will be rejected without further evaluation.
 - (c) Section-9 Part-B (Price Schedule): Prices are not filled in as prescribed in price schedule.
 - (d) Section-4 Clause 9.3 on discount which is reproduced below:-"Discount, if any, offered by the bidder shall not be considered unless specifically indicated in the price schedule. Bidders desiring to offer discount shall therefore modify their offer suitably while quoting and shall quote clearly net price taking all such factors like Discount, free supply etc. into account".
- 29.2 Before outright rejection of the Bid by Bid-opening team for non-compliance of any of the provisions mentioned in Clause 31.1(a), 31.1(b) of Section-4, the bidder company is given opportunity to explain their position, however if the person representing the company is not satisfied with the decision of the Bid opening team, he/they can submit the representation to the Bid opening team immediately but in no case after closing of the tender process with full justification quoting specifically the violation of tender condition if any.
- 29.3 Bid opening team will not return the bids submitted by the bidders on the date of tender opening even if it is liable for rejection and will preserve the bids in sealed cover as submitted by taking the signatures of some of the desired representatives of the participating bidder/companies present on the occasion.
- 29.4 The In-charge of Bid opening team will mention the number of bids with the name of the company found unsuitable for further processing on the date of tender opening and number of representations received in Bid opening Minutes and if Bid opening team is satisfied with the argument of the bidder / company mentioned in their representation and feel that there is prima-facie fact for consideration, the In-charge of the bid opening team will submit the case for review to Officer competent to approve the tender as early as possible preferably on next working day and decision to this effect should be communicated to the bidder company within a week positively. Bids found liable for rejection and kept preserved on the date of tender opening will be returned to the bidders after issue of P.O. against the instant tender.
- 29.5 If the reviewing officer finds it fit to open the bid of the petitioner, this should be done by giving three (working) days' notice to all the participating bidders to give opportunity to participants desirous to be present on the occasion.

30.0 NEAR-RELATIONSHIP CERTIFICATE:

30.1 The bidder should give a certificate that none of his/ her near relative, as defined below, is working in the units where he is going to apply for the tender. In case of proprietorship firm certificate will be given by the proprietor. For partnership firm certificate will be given by all the partners and in case of limited company

- by all the Directors of the company excluding Government of India/ Financial institution nominees and independent non-Official part time Directors appointed by Govt. of India or the Governor of the state and full time Directors of PSUs both state and central. Due to any breach of these conditions by the company or firm or any other person the tender will be cancelled and Bid Security will be forfeited at any stage whenever it is noticed and IIFT will not pay any damage to the company or firm or the concerned person.
- **30.2** The Company or firm or the person will also be debarred for further participation in the tenders in the concerned unit.
- **30.3** The near relatives for this purpose are defined as:-
 - (a) Members of a Hindu undivided family.
 - (b) They are husband and wife.
 - (c) The one is related to the other in the manner as father, mother, son(s) & Son's wife (daughter in law), Daughter(s) and daughter's husband (son in law), brother(s) and brother's wife, sister(s) and sister's husband (brother in law).
- **30.4** The format of the certificate is given in Section 6 (B).

31.0 VERIFICATION OF DOCUMENTS AND CERTIFICATES:

- **31.1** The bidder will ensure that all the documents and certificates submitted by him are correct and genuine before enclosing them in the bid. The onus of proving genuineness of the submitted documents would rest with the bidder.
- 31.2 If any document / paper / certificate submitted by the participant bidder is found / discovered to be false / fabricated / tempered / manipulated either during bid evaluation or during award of contract or thereafter, then the purchaser will take action as deemed fit.
- **32.0** The Vendor has to indemnify IIFT against loss of input tax credit to IIFT on account of blacklisting of supplier during tenure of contract.
- 32.1 The bidder should have a registered office in Kolkata.
- 33.0 No separate fee for Uniform will be charged by the vendor nor should it be deducted from the wages of Employees deputed in the Institute. The bidders may quote accordingly.
- 34.0 For any violation of tender terms & conditions, penalty up to Rs.10,000/- may be imposed by the Institute.
- 35.0 The successful bidder should depute a person who shall be the point of contact for all official purposes. The person should be well aware of the tender terms & conditions.
- 36.0 Any vendor who has worked with IIFT and violated any of the tender terms & conditions in past three years are barred from participating in this tender.

SECTION - 5 (PART - A)

GENERAL (COMMERCIAL) CONDITIONS OF CONTRACT (GCC)

1.0 APPLICATION:

The general condition shall apply in contracts made by the purchaser for the procurement of Security Services.

2.0 PERFORMANCE GUARANTEE:

- (a) The bidder (including NSIC / MSMEs who are registered with the designated bodies) shall furnish performance Bank guarantee in the form of Bank Guarantee from any Scheduled Commercial Bank to the purchaser for an amount equal to 3% of the value of purchase order within 14 days from the date of issue of Purchase Order by the purchaser.
- (b) The proceeds of the performance guarantee shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete its obligations under the contract.
- (c) The performance guarantee Bond shall be in the form of Bank Guarantee issued by a scheduled Bank, valid for 18 months, in the Performa provided in Bid Document.
- (d) The performance guarantee Bond will be discharged by the purchaser after completion of the bidder's performance obligations including any warranty obligations under the contract.

3.0 QUALIFICATION FOR SECURITY PERSONNELS:

The security personnel's recruited should be in accordance with the standards defined in the **Private Security Agencies Central Model Rules**, **2020**.

4.0 LABOUR REGULATIONS:

- (a) The contractor shall obtain a valid labour licence under the Contract Labour (R&A) Act 1970 and the Contract Labour (R&A) Central Rules 1971, before commencement of the work, else he will not depute more than 19 persons at a time on any day. A copy of labour licence has to be submitted by him to IIFT. He shall continue to have a valid licence until the completion of work. The contractor shall also abide by and comply with the provisions of the Child Labour (Prohibition and Regulation) Act 1986, Payment of Wages Act 1936, Minimum Wages Act 1948, Employees Liability Act 1938, Workmen's Compensation Act 1923, Industrial Dispute Act 1947, Maternity benefits Act 1961, Apprentices Act, 1961, EPF & Misc. Provisions Act 1952 and ESI Act 1948 or the modifications thereof or any other laws relating thereto and the rules made there under from time to time. The contractor is fully responsible to observe the above laws as amended from time to time in regard to his employees and compensation and other benefits / risks in relation to employees to be engaged by him.
- **(b)** The contractor shall indemnify IIFT against payments to be made for the observance of the laws.
- (c) The regulation aforesaid shall be deemed to be part of this contract and any breach thereof shall be deemed to be a breach of this contract.
- (d) IIFT shall have the right to deduct from the money due to the contractor, any sum required or estimated to be required, for making good the loss suffered by a worker or workers, by reason of non-fulfillment of the conditions of the contract of the benefit of the workers, non-payment of wages or of deduction made from

his / their wages which are not justified by their terms of the contract for non-observance of the Regulations. In the event of any loss / damages caused directly or indirectly to IIFT, the same will be payable by the contractor along with such penalty as may be decided by IIFT which shall not be less than 10 percent of the total loss suffered by IIFT.

5.0 SAFETY REGULATIONS

During the execution of work, unless otherwise specified the contractor shall at his own cost provide all materials and execute all work necessary for the safety of the Institute and shall ensure that no damage, injury or loss is caused or is likely to be caused to any person or property. The contractor shall be responsible to take all precautions to ensure the safety of the property whether of public or Institute and shall post such security personnel as in the opinion of the officer in charge as per the requirement.

6.0 STATUS OF THE CONTRACTOR AND ITS STAFF MEMBERS:

- (a) The contractor shall have the legal status of an independent contractor. Neither the contractor nor its staff members, nor any person employed by the contractor or its agents for the performance of the services under the present contract shall be considered in any way as being staff members of IIFT.
- (b) The IIFT shall accept no liability for, nor any financial or other consequences arising from, sickness, injury, damages or death of the personnel of the contractor or of any person performing on their behalf any work under the present contract, including the time spent in travel, nor for any damages which may arise by reason of the neglect or default of any of them.
- (c) The contractor shall indemnify and hold harmless the IIFT in respect of any claim arising out of the contractor or its staff member's negligence or unlawful performance under the present contract for any liability as referred to in paragraphs 6(b) above, including their heirs and assigns, or by third parties.
- (d) For the purposes of this article, the term third party shall be deemed to include "inter-alia" officials of IIFT and its agents and officials, as well as any person or entity employed by the contractor or engaged for the contractor, in order to perform services for, or supplying goods to the contractor in connection with the implementation of the present contract.
- (e) Notwithstanding anything to the contrary contained in this contract, the contractor shall only be liable, and shall only be required to indemnify the IIFT, in respect of claims or liabilities that arise out of the negligence, breach of contract or unlawful conduct of the contractor or its staff members or agents in the performance of this contract.

7.0 RESPONSIBILITY FOR PAYMENT OF WAGES:

- The contracting agency will be required to make payment of wages to the staff provided by it at the
 Institute's campus as per Minimum Wages Act of Govt. of West Bengal in force from time to time. As
 and when these wages are revised by the Government, the contracting agency shall accordingly make
 payment of wages to their workers as per revised rates and claim reimbursement from the Institute
 accordingly.
- The contracting agency will ensure payment of wages to the staff deployed by it at the Institute's campus by Seventh Day of Every Month, irrespective of the fact whether the payment of its bill submitted to IIFT has been released by the Institute or not by that date. If seventh day of a particular month happens to be a holiday, the agency may be required to make payment of wages to its staff on a working day prior to the seventh day of such month.

8.0 SCHEDULE OF SUBMISSION OF BILLS:

Monthly bill shall be submitted by the end of the following month. Payment will be made within 15 days' time from the date of submission of the bill in duplicate along with necessary documents, complete in all respect i.e. along with all statutory compliance documents and attendance sheet in respect of the person's deployed statutory deduction such as TDS etc. shall be made from the payment due to agency.

9.0 PAYMENTS:

- Payments will be made through RTGS (Real Time Gross Settlement) or NEFT (National Electronic Fund Transfer) as the case may be.
- Mandate willing to receive e-payments signed by authorised signatory of vendor shall be submitted by the vendor containing following information at the time of signing of Agreement / Contract.
 - (a) Account beneficiary's name.
 - (b) Account type.
 - (c) Account number.
 - (d) Name of the bank.
 - (e) Bank Branch's NEFT code.
 - (f) IFSC code in case of Transfer through RTGS.
- The payment would be made on monthly basis on verification of attendance sheets, wage register, monthly ESIC/EPF/Service Tax Challan/Deployment sheets / Duty Roster / Satisfaction Report duly signed by HOD of the concerned areas, documents in support of salary disbursement through ECS. Workers of contractors should get the wages on the seventh day of each month. The payment of wages shall not be linked to the payment of bill by INDIAN INSTITUTE OF FOREIGN TRADE. If the contractor fails to provide proof of payment of statutory dues, his contract shall be terminated. The Security Agency shall make payment of monthly wages (as quoted in the Financial Bid) to the deployed staffs by ECS only. Cash payment receipt will not be entertained and payment in cash will be deemed as no payment at all. If the agency does not make payment through ECS, the contract will be terminated.

10.0 DEDUCTIONS:

In case the contractor fails to execute / perform the assigned works or part thereof, IIFT shall be authorized to make suitable deductions as deemed fit by IIFT from the bills of the contractor and damages will be charged to the extent of loss.

11.0 PRICES:

Prices charged by the bidder for services performed under this contract shall not be higher than the prices quoted by the bidder in its Bid.

12.0 SUBCONTRACTS:

The bidder shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in its bid. Such notification, in its original bid or later shall not relieve the supplier from any liability or obligation under the Contract.

13.0 DELAYS IN THE SERVICE PROVIDER'S PERFORMANCE:

(a) Start of services and performance of the services shall be made by the bidder in accordance with the time schedule specified by the purchaser in its work order. In case the services are not started in the stipulated time period, as indicated in the Work Order, purchaser reserves the right to short-close / cancel this purchase order and forfeit his performance guarantee or recover liquidated damage charges.

14.0 LIQUIDATED DAMAGES:

The contracting agency would be expected to maintain high standards of security services.

- a. Any <u>serious lapse</u>* noticed by the said officers/committee members would attract minimum penalty of **Rs.10,000/-** (Rupees Ten thousand only) in the first instance.
- b. Any <u>minor lapse</u>** noticed by the said officers/committee members would attract minimum penalty of **Rs.1,000/-** (Rupees One thousand only) in the first instance.

"Serious and Minor" lapses are to be decided by the competent authority. It is to be also noted that any loss or damage to the Institute's moveable or immoveable property due to the conduct of the Contractor's staff shall be made good by the contractor. The value of the loss will be decided by the Institute based on accounting principles/market value.

The decision of the Institute in this regard will be final and binding on the agency. Such decision(s) of the Institute shall be binding on the contracting agency.

15.0 ACTION BY PURCHASER AGAINST BIDDER(S) / VENDOR(S) IN CASE OF DEFAULT:

In case of default by Bidder(s)/ Vendor(s) such as:-

- (a) Failure to deliver and / or commission any or all of the services within the time period(s) specified in the contract, or any extension thereof granted by the purchaser.
- (b) Failure to perform any other obligation(s) under the Contract; and
- (c) If the contractor persistently neglect to carry out his obligation under the contract and / or commits default in complying with any of the term and the condition of contract and does not remedy it or take effective steps to remedy it within the time specified after a notice in writing is given to him in that behalf by purchaser.
- **15.1** When the contractor has made himself liable for any of the cases aforesaid, the IIFT shall have the powers to terminate the contract as aforesaid and forfeit performance guarantee.

16.0 FORCE MAJEURE:

- (a) If, at any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (hereinafter referred to as events) provided notice of happenings of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance, and deliveries under the contract shall be resumed as soon as practicable after such an event come to an end or cease to exist, and the decision of the purchaser as to whether the deliveries have been so resumed or not shall be final and conclusive. Further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reasons of any such event for a period exceeding 60 days, either party may, at its option, terminate the contract.
- (b) Provided, also that if the contract is terminated under this clause, the purchaser shall be at liberty to take over from the bidder at a price to be fixed by the purchaser, which shall be final, all unused, undamaged and acceptable materials, bought out components and stores in course of manufacture

^{*}Serious lapse - Absent of security staff from the post without any prior intimation to IIFT official in charge or engaging in any scuffle by the security staff which defaces the Institute.

^{**}Minor lapse - Dereliction of duty by the security staff while on post.

which may be in possession of the Supplier at the time of such termination or such portion thereof as the purchaser may deem fit, except such materials, bought out components and stores as the bidder may with the concurrence of the purchaser elect to retain.

17.0 EXTENSION OF CONTRACT:

IIFT will have the right to extend this contract on the same rates, terms & conditions at one time or in spells of lesser time period up to a cumulative maximum period of six months or till an alternative arrangement is made whichever is earlier. Extension beyond 6 months on the same rates, terms and conditions will be mutually agreed upon.

18.0 TERMINATION FOR INSOLVENCY

If the supplier/service provider becomes bankrupt or otherwise insolvent, the purchaser may terminate the contract by giving written notice to the supplier/service provider, without any compensation to the supplier/service provider, provided, that such termination will not prejudice or affect any right of action or remedy which has accrued and/ or will accrue thereafter to the purchaser.

19.0 ARBITRATION:

- (a) Except as otherwise provided elsewhere in the contract, in the event of any disputes, controversy or differences arising out of or related to this agreement or the breach, termination or invalidity thereof between the parties, such party or parties shall make a request to the other party or parties to amicably settle such differences or disputes and parties shall thereupon make every effort to settle the same amicably within a period of 60 (Sixty) days from the date of making of such request.
