**Job Profile**

Interns as EFC Associates will be trained and placed in the respective EFCs established by IIFT in different states in collaboration with Government bodies. EFC Associates will be acting as the first point of contact of the EFC. The person will be expected to provide export counselling, collecting, sharing, or disseminating the requisite information raised by the entrepreneurs for exports of the state. The EFC Associates are also expected to contribute on research activities undertaken by the EFC.

**Essential Qualification:**

The minimum qualification required for the Interns is Post Graduation with at least 55% of marks. Candidates should be a Post Graduate in any discipline preferably in Economics/International Business/ Management or related discipline with good academic record and should possess excellent command over written and spoken English and well- versed in handling data in computer. Experience of carrying out data collection & analysis, prior experience in handling export database/ export research and degree/ diploma on export import management will be preferred.

The candidate would be expected to work hard and travel in India and overseas on short notice.

The candidate also required to come on Saturdays / Sundays, as and when needed. For this, the candidate will be compensated as per Institutional regulations with the approval of the Head of the Division concerned.

**Desirable Qualification**

Minimum three years of working experience in Export related services in Government / Autonomous / Statutory Bodies.

The appointment will be purely on contractual basis. The tenure will be fixed & extended depending upon performance of the candidates and requirement of the Institute.
