### SECTION - 3

### ABOUT THE INSTITUTE & SCOPE OF WORK.

- g) Air Handling Units 21 Nos.
- h) Electric Panel and Boards installed for aforesaid equipment's including Repair and Replacement of ACB, MCCB, MCB Relay and Contactor etc.)
- 4. The normal operation timings of the Plant is as stated above at Sl no. 2. The Agency must ensure deployment of one person at plant during operation time. Overtime for the extra hours shall be paid by the Institute.

#### DAILY

**COOLING TOWER:** Check water level before starting the plant. Ensure that the make-up water system is working properly and there is sufficient water in the make-up water tank. Check spray of cooling tower nozzle. Cooling Tower being open, collect lot of muck and dust. Clean cooling tower sump, drain and refill, whenever required. Cooling Tower water may require cleaning due to increased concentration of dissolved solids.

**CHILLED WATER SYSTEM:** To check the water level in the expansion tank and ensure the makeup water system is working satisfactorily.

**CRANK CASE HEATER OF THE COMPRESSOR:** It is very important that the crank case heater comes 'ON' automatically when the compressor is stopped. Do not start the compressor unless the crankcase is warm on physical touch.

**OIL LEVEL IN COMPRESSOR:** This should be about ½ of the side glass. If this level is not maintained, it is a positive indication of malfunction in the plant. If the oil level in the compressor goes down, never fill in oil to make up the level. The only correct step is to find out the reason for the poor oil return and rectify it. Be alert to observe any unusual noise and vibration, it may amplify and cause serious problems. Check for overheating of any part of the plant.

**LOG BOOKS:** Even though logging the readings is a part of the operation, it is these readings that tell the real condition of the plant. If the readings show any abnormality, there is some malfunctioning somewhere and this has to be investigated and rectified without delay. The Log book forms an important maintenance tool for day to day operation of the plant; as well as for future reference.

#### WEEKLY

**CLEAN AIR FILTERS:** A dirty filter can reduce the plant capacity. More the dirt accumulation in the air filter, greater will be the reduction in capacity of the plant. Air filters, if not cleaned regularly will get saturated with dust and thereafter dust will pass on to the cooling coil fins, which will affect plant capacity much more and in extreme cases can even lead to liquid flow back to the compressor, which is highly injurious to the compressor. The dust will form a crust on the coding being wet. Hence, air filters are to be cleaned regularly. Weekly cleaning has been suggested, but whenever required it may be cleaned at lesser intervals. In addition to above, AHU filter has to be taken out of plant and to be washed with water for removing dust. The filter has to be refitted after drying.

**LEAK TESTING FOR REFRIGERANT LEAK:** Soap solution should be used to locate the leaks. New electronic leak detectors are available. While leak testing, the approach should be to find a leak rather than taking it for granted that there won't be any leak and doing the work of leak test as ritual. Even a minor leakage can lead to lot of problems, such as poor oil return, heating of compressor apart from poor cooling.

**WATER PUMP GLANDS:** Check for excessive water leak, through the pump glands. Dropping of certain amount of water through the gland is necessary to keep the gland cool. However, if the drip develops into regular flow, it is an indication that the gland is not holding well. The gland can be tightened to reduce the leak. When tightening the nuts does not improve the situation; the gland packing has to be renewed. If this is not in time, water consumption will go up and in chilled water pump, a water leak means, and loss of refrigeration.

**CLEAN THE WATER STRAINERS:** A clogged strainer reduces water flow rate and thus affect the plant performance. Further, if the strainers are not cleaned regularly, the dirt/muck will form a crust and it becomes difficult to clean. This can even puncture strainer mesh, necessitating replacement of the strainer element. Though the strainer may look to be too small an item, it plays a very important role in keeping the heat exchanger surfaces clean and efficient.

**BELT TENSION OR BELT DRIVES:** Check the tension of belts and tighten whenever found loose. A loose belt will reduce transmission efficiency and its own life will be reduced. Further, the drive pulleys can get heated up. Replace belt when it is not possible to tighten them together. In multi belt drives, change the complete set of belts. Select the belts of matched set. If this is not done, the load will be taken only by the smaller length belts, thereby affecting transmission efficiency and belt life.

### **PREVENTIVE MAINTENANCE**

As the name implies, preventive maintenance is a planned service program. This helps in minimizing major breakdown, to operate the plant at design efficiency and also to save energy.

### QUARTERLY PREVENTIVE MAINTENANCE.

1. Check various pressures, temperature and current from log books and analyse the readings

to ascertain the condition of the plant & take necessary action for rectification.

- 2. Ensure that the oil return is proper.
- 3. Check the crank case heater for proper operation.
- 4. Carry out a thorough test for refrigerant leak.
- 5. Inspect the condition of the filters. Replace them if they are out off shape.
- 6. Check the operation of all safety and operating controls.
- 7. Check alignment of belt and direct drives and belt tension.
- 8. Inspect the cooling tower for proper operation.
- 9. Check all bearing surfaces for abnormal heating vibration and noise.
- 10. Check drains for free flow and clean when required.
- 11. Check cooling coil fins for dirt accumulation. Clean if required.
- 12. Check that electrical connections are proper.
- 13. Check for tightness of all fasteners.

### HALF YEARLY

### CONDENSER

Keep the heat exchanger surfaces clean. In case of water cooled condenser, if the temperature difference of entering and leaving water is more than  $12^{\circ}$  Fahrenheit or  $6.6^{\circ}$  Celsius, the water tubes are to be cleaned. The frequency of cleaning the tubes will depend upon the quality of water used.

**COOLING COIL:** An increase beyond the designed temperature difference between the entering and leaving chilled water or designed temperature difference between entering chilled water and the leaving supply air indicate that the coils require cleaning. Cooling coils are to be cleaned with water under pressure.

### **REFRIGERANT CHARGING:**

If the system has lost refrigerant gas due to leaks, broken connections, etc., this gas must be replaced in order to ensure proper action. It is important that no gas be added until all leaks haves been repaired. Shortage of refrigerant may be indicated by any of the following symptoms.

- 1. Distinct hissing sound from expansion valve
- 2. Low suction pressure and low condensing pressure.
- 3. Numerous bubbles at the liquid level indicator on the liquid line.
- 4. Presence of oil at the leaking joint, connection, bolt head

### TO ADD REFRIGERANT TO THE SYSTEM, FOLLOW THE PROCEDURE GIVEN BELOW:

- 1. Back seat the compressor suction shut off valve. Remove the plug from the gauge port.
- 2. Connect the charging line from the refrigerant drum to the gauge port but before tightening the connections, ensure that all air is purged from the line by cracking the outlet valve on the refrigerant drum.
- 3. Keep the refrigerant drum in a vertical position with the outlet connection on top so that, only gas can enter the system.
- 4. Start the compressor. Crack the suction valve off the back seat and open the refrigerant drum valve. Gas will start following into the system. Charge the systems slowly. Stop the charging every two or three minutes allow the system to stabilize and check suction pressure, liquid indicator etc. Repeat this process of charging until the system is fully charged.
- 5. Watch the liquid level indicator and the suction pressure gauge. When the bubble disappear and the suction pressure is normal, close the drum valve, back seat the Compressor shut off valve, remove the charging line and plug the gauge port.
- 6. Check the oil level.

Whenever, as system is provided with a charging valve in liquid line, it is recommended that this should be utilized in preference to the gauge port on the suction valve.

### YEARLY

- 1. Carry out chemical cleaning of evaporator coils.
- 2. De-scaling of condenser.
- 3. Tighten motor terminals.
- 4. Check all the bolts and nuts for tightness and tighten.
- 5. Checking the motor and starters for performance and ensuring the overall healthy condition of the plant.
- 6. Taking a set of readings and then evaluating them to ensure satisfactory performance of the plant.

### EXCLUSION

- 1. Rigging , Lifting, Shifting and transportation of Chiller equipment/compressor /AHU/Pump/Motor etc.
- 2. Replacement of water piping and all types of valves, flow switch associated with water piping such as Gate Valve, Globe Valve, NRV, Modulation and mixing Valve, Makeup

Water, expansion tanks, Cooling towers fills, Cooling Tower Fan Blade, Cooling tower gear box and insulation works.

- 3. Any damages to the compressor, equipment/system due to external source and tube leakage in evaporator and condenser. All the reappearing work as well as spare parts required shall on chargeable basis.
- 4. Replacement components/equipment of chiller like compressors, microprocessor panels, evaporators, condensers, oil separators, Motor etc.
- 5. BMS of the HVAC system.
