- (III) Vendor has to deposit applicable TCS and GST (as per applicable rates) in addition to the value of goods.

- (IV) All goods must be transported/lifted within 48 hours from the date of receipt of order, otherwise the institute will not be liable for any damages.

(v) If the Buyer does not purchase the Goods after the order is placed, the EMD of the Bidder shall be forfeited. In addition, buyer shall be debarred by the institution from submitting his/her bids for the next 3 years.

(vi) The cost of labour and transportation for carrying the goods shall be borne by the buyer himself.

(vii) IIFT reserves the right to reject any or all the bids or cancel/withdraw the invitation for bid without assigning any reasons whatsoever thereof. IIFT does not bind itself to accept highest bidder.
