Indian Institute of Foreign Trade is an autonomous body under Department of Commerce, Govt. of India. It has two built up Campuses at Delhi and Kolkata. The Institute is also in the process of constructing two new campuses at Maidan Garhi in Delhi and Kakinada in Andhra Pradesh apart from undertaking major repairs/ renovation works at its existing Campus in New Delhi.

The Institute intends to engage an experienced Engineer (On Contract) from Central Government/ State Government/ PSUs/ Autonomous Bodies of the Central/ State Government.

Eligibility:

- i) B.Tech/ M.Tech in either Civil or Electrical Engineering
- ii) Minimum 10 years working experience at pay level of L-10 in Engineering field (PB-3 + 5400 G.P.) or above of working in CPWD/ State PWD/ MES or similar organized services/ semi-Govt. / PSU/ Statutory or Autonomous Organisation/ Universities/ reputed Institute or organisations under Central/ State Government.
- iii) Prior experience of handling/ managing at least one project costing Rs 100 crore or more.

Desirable:

- i) Proven track record of handling/managing projects work in reputed organisations of relevant magnitude and qualities.
- ii) Experience of working in civil engineering, designing and estimation, construction management etc., as relevant to the profession.
- iii) Proficiency in the use of a variety of computer office applications, MS Word, MS Excel, Power Point or equivalent is must.

Tenure

The appointment will be purely on contract basis initially for a period of one year. The tenure may be extended further depending upon performance of the candidate and requirement of the Institute.

Age: Should not be more than 62 years on the last date for application.
