## Engagement of Resident Paramedical Staff on contractual basis

The Indian Institute of Foreign Trade (Deemed to be a University) is a premier Institution set up by Department of Commerce, Government of India, engaged in education, training and research in the area of international trade and business.

Applications are invited to fill up the **one** post of Paramedical Staff in IIFT, New Delhi on contractual basis for a period of one year and which may be renewed for similar term by Competent Authority, on the basis of performance of the incumbent and the future requirement of the Institute. The engagement will be purely on contractual basis and the incumbent shall have no claim for regularization.

## (1) <u>Resident Nurse</u>- 01 Position

## (I) Essential qualification and work experience:

- (i) Certificate as Registered Nurse and Midwife having passed
- (ii) 03 years course in General Nursing and Midwifery from a school of Nursing or other institution recognized by the Indian Nursing Council

(OR)

B.Sc. (Nursing).

(iii) At least 02 years of post-qualification experience.

Note: The Indian Nursing Council has also laid down certain special concessions for the above courses in respect of Auxiliary nurse Midwives, Midwives and 'B' Grade Nurses, by way of reduced course period etc. Candidates obtaining the qualification prescribed above, under these concessions will also be eligible for recruitment.

(II) Emoluments: The candidate will be paid a consolidated salary of Rs. 45,000/- per month.

**(III) Tenure:** The appointment will be purely on contract basis initially for a period of one year. The tenure may be extended further depending upon performance of the candidate and requirement of the Institute.

(IV) Age: Should not be more than 55 years at the time of receipt of application.

**(V)** Accommodation Facility: Paramedical Staff will be required to stay in the accommodation provided in the campus of the IIFT, New Delhi.

(VI) Joining: Selected candidate is expected to join immediately after receipt of offer.

- Fulfillment of conditions of minimum qualification shall not necessarily entitle any applicant to be called for further process of recruitment.
- In case of large number of applicants, IIFT reserves the right to short-listing applications in any manner as may be considered appropriate and no reason for rejection shall be communicated in any case.
- IIFT reserves the right to fill or not to fill the post advertised. No correspondence whatsoever will be entertained from the candidates regarding conduct and result of test/ interview and reasons for not being called for interview.
- No TA/DA in connection with the submission of application form or appearing in the test/ interview will be paid to the candidate.
